1. 前言

- a. 「型·男家族」(以下簡稱「比賽」)由新時代電視及電視廣播有限公司(TVB)(以下簡稱「主辦機構」)主辦,任何人士若符合下述條件者均可參加(以下簡稱「參賽者」),比賽分評選面試及決賽進行。
- b. 主辦機構有權自行決定製作有關之電視節目及進行電視廣播、錄影碟製作、網上廣播及任何形式之廣播。
- c. 參賽者同意遵守下列之一切申請條件及規則。

2. 參賽資格

- a. 參賽者必須在二〇一七年五月十八日或之前,以西曆計算,年滿十六歲。
- b. 根據參賽者提供的資料,主辦機構有權豁免及放寬上述參賽條件。
- c. 參賽者必須不受任何合約束縛,以致不能簽署及履行主辦機構之合約。

5. 同意聲明

- a. 參賽者明白及同意主辦機構有權隨時:

1. Foreword

- a) Project Boyz Power Vancouver 2017 (hereinafter the "Contest") is organized by Fairchild Television Ltd. and Television Broadcasts Ltd. (TVB) (hereinafter the "Organizer"). It is open to applicants (hereinafter the "Contestant") who satisfy the requirements set out below.
- b) The Organizer shall have the absolute right to broadcast the contest as a television programme as well as in DVD, Internet and any other media formats.
- c) The Contestant agrees to be bound by the terms and regulations listed below.

2. Qualifications of the Contestant

- a) The Contestant shall have attained the age of 16 on or before May 18th, 2017. All dates and ages shall be calculated according to the Gregorian calendar.
- b) The Organizer shall have the right to waive or modify the above qualifications in relation to any Contestant with regards to the information provided by the Contestant.
- c) The Contestant shall not be bound by any legally binding agreement, which will prevent or prohibit him from entering the contract with the Organizer.
- d) The Contestant must not be an employee of the Organizers Fairchild Television or Television Broadcasts Ltd. (TVB), Co-organizers Talentvision, Fairchild Radio or Popular Lifestyle & Entertainment Magazine.

3. Contesting procedures

- a) The Contestant shall complete and sign the application form, and must submit together with the application form the following documents and fee:
 - i) photocopy of the Contestant's driver's license or passport or other valid picture identification document;
 - ii) 2 photographs: one showing him in half length and the other in full length;
 - iii) an application fee:
 - Regular (on or before May 18th): CAD \$30.00
 - Drop-in (May 20th): CAD \$40.00

- c) The deadline for application is May 18th, 2017 (Thursday) at 5 pm.

4. Dates of various contests

- a. Audition: May 20th, 2017 (Saturday)
- b. Final: July 29th, 2017 (Saturday)

5. Declarations

- a. The Contestant understands and agrees that the Organizer has the absolute right at any time to:
 - i) refuse any application without having to give any explanation;
 - ii) select any Contestant to enter into the preliminary;
 - iii) disqualify any Contestant from competing without having to give any explanation;
 - iv) amend or cancel the dates and venues of the auditions and the final.
- b. The Contestant further agrees:
 - i) that the Organizer need not to return and can retain the documents and application fee described in clause 3;
 - ii) that the Organizer need not to compensate or in any way be responsible for any loss of the Contestant but not limited to personal and fatal injuries;
 - iii) to be bound by the decision of the Organizer and the panel of judges;
 - iv) to be bound by the decision of the Organizer in relation to the hair-style, make-up and costume of the Contestant;
 - v) to participate in the promotional activities arranged by the Organizer and to obey the reasonable and lawful directions of the Organizer pursuant to such promotional activities;
 - vi) that all Final Contestants are required to enter into a one year management contract with Fairchild Television Ltd.

6. Confirmation

The Contestant confirms that the information given in this application form is true and correct.

7. Language

This text is written in both English and Chinese. In case of variance or discrepancies between the two versions, the English version shall be final.

Fairchild Television Ltd. shall retain the contestants' personal information for the promotion and production of Project Boyz Power Vancouver 2017.
